
#### CUSTOMS B2C & B2B deliveries all over Europe

- Custom's clearances B2B:
- B2B deliveries: always duties & VAT
- Custom's clearance procedure;
- For each product we need an e-Commerce reference no. (example Amazon -> ASIN = Amazon Standard Indentification Number)
- Value on invoice must be minimal 60% of the retail price. Retail price will be checked through e-Commerce referebce no. On Amazon, Ebay, etc. website.
